Form for Determining Family Tuition

1. Find the column with the family's size written at the top
2. Read down the column until you come to the closest monthly income*
3. Then read directly across to the right to determine the fee

*To calculate a monthly income from a weekly income, multiply the weekly income by 4.33.

*To calculate a monthly income from a bi-weekly income, multiply the bi-weekly income by 2.17.

Families that apply for and meet the USDA's Income Eligibility for Free Lunch through the Federal School Lunch Program will automatically qualify for 100% reduction in Kindergarten Tuition. Families that apply for and meet the USDA's Income Eligibility for Reduced Lunch through the Federal School Lunch Program will automatically qualify for 75% reduction in Kindergarten Tuition.

Families that have more than one student concurrently enrolled in the full day kindergarten program will be eligible for a 35% sibling discount that will be applied to each student's tuition. In the event that a family is eligible for both a sibling discount and income based financial assistance, the sibling discount will be applied first.
